

Embracing Ethical Al

Monoceros looks at the Bletchley Park Declaration

1. What is the Bletchley Park Declaration?

On 1 November 2023, the Bletchley Park Declaration (the "Declaration") was signed at the AI Safety Summit. The Declaration is a collective pledge by 28 leading AI nations to create a framework of ethical AI standards in artificial intelligence ("AI") development.

It champions transparency, fairness, accountability, and human rights for responsible Al innovation. It also warns about the "potential for serious, even catastrophic, harm, either deliberate or unintentional, stemming from the most significant capabilities of these Al models." These risks extend beyond "frontier Al" to data bias and data privacy.

2. Key points:

The Declaration addresses:

- Frontier Al risks: The declaration acknowledges the potential benefits and challenges of frontier Al, and the need for international cooperation to mitigate the risks posed by Al systems that may be harmful, unpredictable, or misaligned with human values.
- Al safety principles: The declaration outlines some general principles for Al safety, such as ensuring human oversight, transparency, accountability, and ethical standards. The declaration also calls for fostering public awareness and education on Al safety issues.
- Al safety research: The declaration supports the advancement of scientific research on Al safety, and the sharing of best practices and data among countries. The declaration also encourages the development of technical tools and methods to ensure the safety and reliability of Al systems.
- Al safety governance: The declaration proposes the establishment of a global AI safety forum, which will be a platform for dialogue and collaboration among countries, experts, and stakeholders on AI safety matters. The declaration also urges the government and the industry to work together to create appropriate regulations and policies for AI safety.

3. Are there other International AI Guidelines?

Yes, in October 2023 in the United States of America, the Biden-Harris Administration issued a landmark Executive Order on Al. The Order establishes new standards for Al safety and security, seeks to protects Americans' privacy, seeks to advance equity and civil rights, consumer and worker protections and promote innovation.





The European Union also issued (and subsequently updated) a draft AI Act that proposes to regulate the use of AI within the EU and establish regulatory principles within a risk-based framework. The draft act focuses on rules around data quality, transparency, human oversight and accountability and addresses ethical matters. The June 2023 amendments seek a ban on the use of AI technology in biometric surveillance and for generative AI systems to disclose AI-generated content.
